





Many were in the Ashland Block (155 North Clark) present site of the Greyhound Bus Station; others in the City Hall Square Building, now part of the site of the new Civic Center, and in the Reaper Block (northeast corner of Washington and Clark Streets), and in similar buildings. With few exceptions, they were all north of Madison Street.

On the other hand, the large law firms that represented big business and industry, the banks, insurance companies and the railroads, were all south of Madison Street - the "line of demarcation."

THE JUSTINIAN SOCIETY

In the fall of 1921, John De Grazia called a meeting of lawyers, in his offices in the Ashland Block, for the stated purpose of organizing a bar association of Italian lawyers. 30 answered the call.

The Justinian Society of Advocates was chartered by the State of Illinois, on October 17, 1921. (The name was amended to Justinian Society of Lawyers - on September 3, 1953.)

On the charter, the incorporators are: John De Grazia, Helen M Cirese, Joseph R. Orrico and George L. Quilici.

De Grazia, the founder of the Society, was elected President, two terms, and served 1921-1923.



In September 1981, was one of the most memorable and joyous day of my legal life, next to the day I found out I passed the bar exam and the day I was sworn in on November 18, 1964, in Springfield, Illinois.

To be selected by your peers to head the greatest ethnic bar association in America is awesome.

The installation dinner in September 1982 was the largest attended ever. There was 780 people in attendance. The affair was so large it had to be moved from the Palmer House to the Americana Congress Hotel.

I was fortunate enough to convince Joseph Cardinal Bernardine to accept an award from our Society which was not easy to do since at first he thought this was a political event. I explained that he was dealing with and interpreting Canon Law and this was an organization that dealt with Common Law.

That same year we started a perpetual fund with \$40,000.00, which I believe is still in existence.

Once again I am truly honored to have served as president and still remain an active member. I thank all past and present members and wish the best success to all present and future members. Grazia Tante!


It was 1982 and the Justinian Society had become one of the most influential ethnic Bar Associations in Cook County. Under the

leadership of past presidents Leonard Amari, Jack Cerone and Charles Porcellino, young Italian American lawyers and law students were provided the opportunity to meet, learn, and enjoy companionship with Italian American Judges and attorneys willing to share their time and experience. A significant stream of mentoring was established by the Society before Mentoring took on greater significance within the legal community in later years. Influenced by Judge Gerald Sbarbaro in 1983, the Justinian Society took on a significant role in the formation of a National Italian American Bar Association. It was a time of forming personal and professional relationships that have lasted a lifetime. *Che Dio vi Benedica*.

RICHARD CAIFANO, PAST PRESIDENT (1982-1983)

At the installation dinner as President of the Justinian Society, I had the honor of introducing "The Prince of the Church" Joseph Cardinal Bernardin. His story parallels many of ours. A story of a hardworking family struggling to see the dream of their son come true. Accompanying myself and the Cardinal is Cook County Alderman Frank Damato.

HON. BRUNO J. TASSONE, RET., PAST PRESIDENT (1984-1985)













My involvement with the Justinian Society of Lawyers has been richly rewarding to me professionally and personally. Although I have been involved in a number of bar associations during my legal career, includ- ing as a past President of the Illinois State Bar Association, none has had more of an impact on me than the Justinian Society, for which I was honored to serve as President in 1992-93. The deep personal long-lasting relationships I have developed with other Justinian members, including all of those who have served as President, have immeasurably enriched my life.

I was proud to serve as President during what was the "quincentenary" (500th anniversary) of Columbus' voyage from Europe across the Atlantic to what is now known as the Americas. There was considerable controversy even then about Columbus as a positive image for Italian-Americans, which I addressed in my inaugural speech, concluding that the positive outweighed the negative. During my term I was proud to have created a Membership Directory with information about members' practice areas to create a more meaningful resource for the Society including as a referral network, expanded the role of Nina Albano Vidmer as Executive As- sistant, whose efforts were invaluable in developing the Society as a more efficient and professionally run organization, and was especially honored to have (finally) turned over the Presidency of the Society to a woman -Gloria Coco - the first in its then 72 year history to serve in that role.

I am proud to be a lawyer, and equally proud of my heritage, and was fortunate and honored to have celebrated and displayed that pride as a Justinian President.



My experience as Sometime in the year of our Lord 1960, around 5-6pm, at 10 years of age, I attended my first Justinian Society of Law yers (JSL) event in the Chicago Room at the Legendary Como Inn with my father, Samuel J. Coco, who was one of the original members of the JSL. I do recall how his colleagues like Mr. Yelmini, John Meccia, James Montana, Mr. Mirabella, Dominic Tesauro, Al Gallo, Carl Cipolla, and Victor Cacciatore, just to name a few, embraced their professional fellowship while celebrating their Italian and Sicilian Heritage coupled with the practice of law!

Often during college, and throughout law school, I attended a number of JSL events which heightened my commitment to the philosophy and importance of Ethnic Bar membership. One day while walking down La Salle Street with my father, he introduced me to a very special attorney Richard Caifano, and the rest is history.

As a young female lawyer in the 80's, I was blessed to experience the fellowship, support, and mentorship of my JSL colleagues who guided, encouraged, and lauded my professional goals. Since women in the law were not as plentiful as now, my fellow Justinians were the brothers, I biologically never had...Justices Scariano, Gigante, Rizzi, Judges Cipolla, Barbaro, Porcellino, Tassone, DiVito, and Pope, Attorneys Amari, Cerone, Caifano, Tornatore, DePalma, Caldarazzo, Locallo, Monico, Erbacci, Gagliardo, Ferraro, Davi, Allegretti, and Bisceglia, etc., etc.!

In 1988, President Joseph F. Locallo afforded me the great honor to become the first female secretary since the JSL was chartered in 1921, with ascendency to the Office of President in 1993. The Honorees of the 1993 Annual Installation and Awards Dinner were Geraldine Ferraro, the First Woman Vice Presidential Candidate of the USA, and actor Dennis Farina who both enhanced the grandeur of the event. Sadly, my father and mother Sam and Grace Coco both died the year before. However, I felt their spirit of celebration and pride the night of my installation as President!

As President, I introduced the First Justinian Mass and Brunch, the calendar cards, and the first Ethnic Bar Presidents Pot Luck Dinner attended by a great JSL supporter, Steve Anderson of the ISBA. The Justinian Society of Lawyers enhanced my professional endeavors, and afforded me the opportunity to cultivate life-long friendships!

ANTHONY B. FERRARO, PAST PRESIDENT (1996-1997)


During my presidency of the Justinian Society of Lawyers, a few of the things that stand out to me include the family trip we took to Washington D.C. and our tour of the White House.
